TITLE 27, CALIFORNIA CODE OF REGULATIONS

CHAPTER 1. SAFE DRINKING WATER AND TOXIC ENFORCEMENT ACT OF 1986

ARTICLE 8. NO OBSERVABLE EFFECT LEVELS

Section 25805. Specific Regulatory Levels: Chemicals Causing Reproductive Toxicity.

Amend Section 25805 (b) as follows:
