The Office of Environmental Health Hazard Assessment (OEHHA) is augmenting the administrative record for the proposal to adopt Title 27, California Code of Regulations, sections 25607.48 and 25607.49.

As required by Government Code section 11347.1(b), OEHHA is giving notice of this augmentation of the record and announcing a 15-day public comment period on the proposed augmentation.

### Background

OEHHA first proposed the regulation by publishing a Notice of Proposed Rulemaking in the California Regulatory Notice Register (CRNR) on July 23, 2021<sup>1</sup>. In parallel, OEHHA issued an Initial Statement of Reasons and draft regulatory language for the proposal. OEHHA provided a 76-day comment period on the original proposal, from July 23 to October 7, 2021. A public hearing was held on September 9, 2021. Following review of the comments on the initial proposal, on April 13, 2022, OEHHA modified the proposal and added documents to the administrative record for this action. The comment period on this action closed on May 5, 2022. Subsequently, OEHHA determined that additional documents should be added to the administrative record.

# **Documents Added to the Record**

The purpose of this notice is to provide the public with notice of the augmentation of the administrative record for this action and to open a 15-day public comment period, running from June 28, 2022, through July 13, 2022. OEHHA is adding the two documents because of the recent 9th Circuit Court decision in <u>NRDC v US</u> <u>Environmental Protection Agency</u> (Case No. 20-70787 and No. 20-70801 – Filed June 17, 2022). Consistent with the Administrative Procedure Act, OEHHA will only address comments received during this comment period that address the documents added to the administrative record.
